# What is Child Safeguarding?

Child Safeguarding refers to the set of policies, procedures and practices that we employ to ensure organisations are itself a child safe organisation.

#### What is Child Protection?

Child Protection means the protection of all children from all forms of physical or mental violence, injury or abuse, neglect, maltreatment or exploitation, including sexual abuse, and the prevention of such violence.
